Black Rock District First Aid Meet

Fees: Scouts— \$6.00

Leaders— \$6.00

Each Patrol must have a first aid kit. Include: blankets, poles for stretcher, triangular bandages, roller gauze, scissors, splint padding (such as small hand towels), wood splints (for arm and legs), gauze compress pads, cloth binders (for binding splints), wash basin. Equipment shall be of the "improvised type" and shall be restricted to that which would be readily available in an emergency. (Metal, commercial type stretchers and traction splints excluded.) **Each Scout should have a personal first aid kit.**

Reference Standards: The Boy Scout Handbook, Field Book BSA, First Aid Merit Badge Book, Emergency Preparedness Merit Badge Book, Safety Merit Badge Book and the Disabilities Awareness Merit Badge Book

Patrols:

- Must have at least **5** scouts but not more than **8**
- Scouts must be in Class A Uniforms
- Patrol Flag would be helpful
- Each patrol must provide an adult leader to be a judge

You are encouraged to invite Webelos Scouts to participate as a victim or to cheer your patrols on.
